Bryce Casidy

What have you done, or will you do to advocate in support of active transportation infrastructure in your city and why?

I will advocate for more bike-centric civic events to help change the culture or our City.

What piece of bike infrastructure is needed next in your city?

Increased bike parking requirements for new developments including more and better designed/safer bike racks outside of businesses.

What will you do to help achieve BC Road Safety Strategy's Vision Zero? (the ultimate goal of zero traffic fatalities and zero serious injuries.)

Bike routes in Pitt Meadows are fairly well distributed throughout the majority of the city. The official Pitt Meadows Cycling Map identifies area of concern for cycling safety. My personal experiences lie with the train crossing at Harris so I will push to include bike lanes in the hopeful soon-to-be underpass. At other points, I believe new markings and or revised curbing may help keep riders safe.

HUB Cycling has released a Cycling Platform. Which focus areas and points do you endorse, and which ones do you disagree with?

While Land Use has certainly played a role in segregating certain communities, I believe Pitt Meadows, as a small tight-knit community is not affected to the same degree.

The infrastructure is the main concern that I would focus on in our community. More safe bike parking is key to give residents a sense of comfort in relying on cycling for daily errands and activities.

I am happy to raise my daughters in Pitt Meadows, a closely-knit community where they may one day be cycling everywhere. I want to ensure that we make it as safe and accessible for them and everyone else in the community.

What have you done, or will you do to advocate in support of active transportation infrastructure in your city and why?

As a member of the Advisory Design Panel and as a council member, I have ensured that cycling lanes have been added to many of the arterial roads in our city and to the design elements of the proposed underpass at Harris Road.

What piece of bike infrastructure is needed next in your city?

There will be a new shared pathway that extends from the Pitt Meadows Athletic Park, along the eastern boundary of GEBP that will connect to the most utilized bike path in the city (The Greenway). This will

ensure traffic free access for cycles north/south in the southern part of the city. This has been built into the design plans of the industrial park and will be a reality in 2023

What will you do to help achieve BC Road Safety Strategy's Vision Zero? (the ultimate goal of zero traffic fatalities and zero serious injuries.)

As a councillor, safety remains top of mind for all decisions. We are building new police station in Pitt Meadows and de-integrating from the joint RCMP contract with Maple Ridge to have an independent RCMP contract for our city. This will provide a significant improvement in safety, traffic related enforcement etc. and reduce the incidence of speeding on our roadways. I will personally be advocating for better controls and safety lighting at pedestrian crossings and for new lighting of the major arterial roads in the southern part of the city. Continued investment in upgraded infrastructure will be part of business planning for the next 4 years which includes everything from sidewalks, multi-use paths, bike lanes, and supporting components such as bicycle parking, traffic calming, and crosswalk improvements.

HUB Cycling has released a Cycling Platform. Which focus areas and points do you endorse, and which ones do you disagree with?

The HUB platform is a well thought out and focussed portal and a valuable tool for councillors to understand the needs for the cycling community and the added benefits to our whole community in terms of safety, recreation and environmental benefit. Our city of Pitt Meadows is quite small in terms of population but enjoys a unique and enviable reputation for it's cycling opportunities. Cycling enthusiasts join our local residents every day to explore the many cycling routes along the many kilometres of dikes and trails within the city. In general terms, I'm in support of the vision and focus of HUB with the proviso that there are many calls on our city budget to support a wide range of recreation activities and to that end we will endeavour to continue the work of improving our cycling opportunities with the transport infrastructure of the city.

What have you done, or will you do to advocate in support of active transportation infrastructure in your city and why?

I volunteer on the Active Transportation Advisory Committee for the City Of Pitt Meadows. We advise the City on strategic priorities and policies relating to the active transportation in Pitt Meadows. When elected, I promise to help identify and correct safety concerns, make cycling and walking in the city more convenient and to continue advocating for safer bike routes. I also plan to walk or cycle to Council meetings whenever possible in the four year term.

What piece of bike infrastructure is needed next in your city?

Safer crossing at Harris Road Train Crossing. Connection between south dykes and city centre. Safer crossing at Kennedy Road, if the new CP logistics park goes ahead.

What will you do to help achieve BC Road Safety Strategy's Vision Zero? (the ultimate goal of zero traffic fatalities and zero serious injuries.)

I will help identify dangerous sites in Pitt Meadows, and advocate for upgrades to make them safer. I want thoughtful development of Pitt Meadows to make sure areas are not disconnected, and thus must rely on a vehicle to shop, go to school or work.

HUB Cycling has released a Cycling Platform. Which focus areas and points do you endorse, and which ones do you disagree with?

I endorse the platform. As we are a growing and developing city, I specifically endorse the point "Support sustainable land use plans and zoning, including densification and building complete communities where people can access all of their daily needs within a 15-minute walk or bike ride, including jobs, groceries, schools and services". We need thoughtful development to make sure we aren't creating pockets of development that are going to have to rely on vehicles to shop, go to work or school, Etc. And as our city is building new roads and the Harris Road underpass, we need to focus on the point "Support, in principle, that people of all ages and abilities should be able to bike to and from major destinations safely and comfortably at all times of day and year". Getting around our city needs to be safe for all ages and abilities, which is currently a challenge along Harris Road and Airport Way.

We have a great city that is know for cycling and active transportation, but as we grow we must make sure we are encouraging more thoughtful development, so that active transportation is possible and safe for all ages and abilities.
